Applicant hereby agrees to abide by each of the terms and conditions set forth on all invoices, which terms and conditions may be amended from time to time, and which terms and conditions are incorporated herein by reference. Applicant hereby understands and agrees that, should it become necessary to place this account for collection, Applicant hereby obligates itself/himself/herself to pay all costs of collection, including but not limited to collection of agency fees, reasonable attorneys fees, court costs, filing fees, interest and service fees which may be charged in the event of default or failure to pay for goods and services provided.
